What personal data we collect and why we collect it

Embedded content from other websites

How long we retain your data

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register on our website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

What rights you have over your data

If you have an account on this site, or have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal

data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

General Privacy Policy from Ciberforma Websites

In order to provide our users with a more complete understanding of how the CIBERFORMA sites collect and use information from our users, we have provided the following information: Internet Protocol (IP) Address.

The CIBERFORMA sites log IP addresses for systems administration, diagnostic, and site tracking purposes, and to report aggregate information to advertisers. The CIBERFORMA sites do not link IP addresses to information identifying users individually.

Cookies

The CIBERFORMA sites may use files called "cookies" to store usernames, passwords, and other user preferences so that users don't have to re-enter this information each time they use a particular CIBERFORMA site. Information Collection and Opt-Out
